



## NCAA Recruiting Rules Comparison: A Resource for Coaches, Recruited Student-Athletes, and Parents

The NCAA rules regarding recruiting are complex, and there are many differences between Division I and Division III rules. Each College Squash Association (CSA) member institution enforces the recruiting rules according to the relevant bylaws of its Division, along with the relevant rules of its conference, if applicable. Conference bylaws may be more restrictive than NCAA bylaws, so coaches should confer with institutional compliance coordinators for complete guidance. While there is no difference in quality between Division I and Division III schools, recruits and parents should always ensure that they know which school belongs to which division.

The table below is a summary comparison of how noteworthy standards and rules are applied in each NCAA division. This comparison is not exhaustive, providing only broad guidance, and any questions that arise from the summary should be answered using the full NCAA manuals, preferably in consultation with an NCAA rules expert or coach.

Before progressing through the comparison table, it is important to understand the definitions of key terms that appear in the NCAA verbiage:

### Definitions

- “PSA” – Prospective Student-Athlete: any student-athlete who has started classes in the 9<sup>th</sup> grade or equivalent
- “Non-traditional calendar” – this term generally refers to academic calendars in the Southern Hemisphere that often do not line up with American or European academic calendars.
- “Contact” - Any face-to-face encounter between a PSA or the PSA’s family members and an institutional staff member or athletics representative during which any dialogue occurs in excess of an exchange of a greeting.
- “Evaluation” - Any off-campus activity designed to assess the academic qualifications or athletics ability of a PSA, including any visit to a PSA’s educational institution (during which no contact occurs) or the observation of a PSA participating in any practice or competition at any site.
